SUBJECT—Modification of delegation of powers to Assistant Conservator of Forests as per the Odisha Forest Code, 1979.

No. 6893—FE-FE2-MISC-0002/2017-F&E.—After careful consideration, Government have been pleased to delegate the following powers and responsibilities to the A.C.F. as per the Odisha Forest Code, 1979 :—

- 1. As per the Odisha Forest Department Code, 1979 every officer who is authorized to receive and disburse Government money should maintain a cash book. Accordingly, a cash book is being maintained by the Range Officer and Divisional Forest Officer in which the entry of all money transaction is made. To execute works in the field, Range Officer submits requisitions of fund to the DFO based on which DFO releases forest advance to the R. O. As per delegation of powers to the Assistant Conservator of Forests, vide No. 2F (Assn.)-1/88 (pt.)-7873 FFAH., dated the 3rd April 1989, the ACFs stationed at Divisional Headquarters and outside the Divisional Headquarters will have to scrutinize the requisition for forest advance of the Ranges under his/her charge. The above ACFs are also delegated with the powers of field checking of muster rolls and measurement books in respect of their jurisdictions. In absence of proper password in the chain of accounting procedure for checking requisition submitted by Range Officers, ACFs being the field supervising officer are unable to go through the instructions of higher office to the Divisions and from Division to Range Office through IFMS and e-mail regarding financial allotment and fund released for execution of various departmental works. Hence, it has been decided to allow them password(s) for all online transactions made by the Division through IFMS to have a transparency in accounting procedure and proper implementation and monitoring of departmental works.
- 2. The delegation of powers to ACFs vide Government order under reference is silent about duties of ACFs for protection of forests and wildlife. As a result, for any illicit felling or poaching, it is the Range Officer and DFO, who are responsible and ACFs cannot be held responsible. It is now decided that ACFs will also henceforth be responsible for any protection problem leading to illicit felling, poaching, encroachment or forest fire wild animal depredation etc. in the Ranges under their jurisdiction. They will supervise the protection works of subordinate staff and the squads.
- 3. ACFs shall also be responsible for attending the meeting on behalf of DFO in various offices within the Division or outside as decided by the DFO.
- 4. Keeping in view of delegation of powers, it is also decided that ACFs shall take active part in execution of all technical works as per the prescribed methodology in the working plans/ schemes, management plans etc. They shall be held responsible for the correctness of all the technical works to be executed within their jurisdictions.

1. OBJECTIVE

The main aim of organizing "State Games" envisages to "Promote Sports Ecosystem" in the State. The key objectives of organizing State Games are :—

- * To inspire, promote and popularize any sports & games in the State among the youth
- * To ensure better match practice and competition environment to athlete/players, this ultimately helps them to improve their standard.
- * To identify prospective talents for advance training/ coaching.

2. DEFINITION

In these rules unless the context otherwise requires-

- (a) State Games means, organization of State level competition in identified sports disciplines
- (b) Odisha Olympic Association means, the apex body of State Sports Associations duly recognized by Indian Olympic Association & approved by Sports & Youth Services Department, Government of Odisha.
- (c) State Association means, a registered State level sports body affiliated to concerned National Sports Federation (NSF), Odisha Olympic Association and Sports & Youth Services Department, Government of Odisha.
- (d) Sports Disciplines means, disciplines recognized by Sports & Youth Services Department, Govt. of Odisha/ Government of India and Indian Olympic Association (IOA).

3. SPORTS DISCIPLINE

1. Archery, 2. Athletics, 3. Football, 4. Hockey, 5. Weightlifting, 6. Badminton, 7. Basketball, 8. Boxing, 9. Handball, 10. Judo, 11. Kabaddi, 12. Karate-Do, 13. Kho-Kho, 14. Swimming, 15. Table Tennis, 16. Taekwondo, 17. Tennis, 18. Volleyball, 19. Wrestling, 20. Ball Badminton, 21. Baseball, 22. Cycling, 23. Gymnastics, 24. Netball, 25. Rifle Shooting, 26. Rowing & Sculling, 27. Sepak Takraw, 28. Softball, 29. Tennikoit, 30. Throw ball, 31. Wushu, 32. Yachting (Sailing), 33. Yoga, 34. Rugby & any other discipline decided by the Government.

4. COMPETITION :

- (i) The competition will be organized in identified sports disciplines once in two years.
- (ii) The sports disciplines in which competition will be conducted is to be decided by the steering committee (to be constituted by Sports & Youth Services Department with approval of Government).
- (iii) Teams sponsored by District Athletic Associations/District Associations including Bhubaneswar Athletic Association affiliated to recognized State Sports Associations, Odisha Olympic Association and approved by Department of Sports & Youth Services, Government of Odisha will only participate in State Games.
- (iv) The duration of the competition will be limited to 7 days.
- (v) Basing on the position of teams and qualifying standard of individuals, the State Level Associations will designate the teams/individuals to participate in State Games in team events & individual events respectively.
- (vi) A database on the competitions of the state games will be maintained.

5. STEERING COMMITTEE :

A Steering Committee will be constituted headed by Hon'ble Minister Sports & Y.S. with members drawn from Odisha Olympic Association and respective State level Associations in the disciplines in which State Games will be conducted. Sports Administrators and Sportspersons of repute shall be a part of the Steering Committee.

6. MODALITIES :

The Steering Committee so constituted by Sports & Youth Services Department, Govt. of Odisha will finalize the modalities of competition (qualifying standard of individual athlete in case of Individual Sports disciplines and qualifying standard of teams in case of team events), the total number of participants in each sports discipline including accompanying officials, the number of conducting officials for all Sports & Games.

7. QUANTUM OF FINANCIALASSISTANCE :

The Department of Sports & Youth services will finalize the budgetary expenditure with approval of Govt. for organizing State Games after obtaining proposal from the Steering Committee. Corporate sponsorship will also be solicited to meet the Budgetary requirement.

7. Only such of the persons who have filed the E.M.D. and solvency shall be allowed to bid.

In case of the representation, valid Power of Attorney duly registered shall be required to be submitted.

8. No person shall be allowed to take part in the auction, if he is listed as a defaulter in this Division.

9. The intending bidders are advised to inspect the lots well in advance prior to taking part in the auction. The act of bidding shall be taken as sufficient proof of the bidder having satisfied himself about the correctness of the quantum and quality of the produce and the area of the contract put to auction. No complaint regarding the quality and the quantity of the produce or the area of contract will be entertained nor shall any claim for grant of refund or rebate will be entertained under any ground whatsoever after the sale is concluded.

10. The sale of lots is subject to the relevant provision of the Orissa Forest Act, 1972, Wildlife Protection Act, 1972 and rules framed thereunder, The Orissa Forest Contract Rules, 1966, the general and special conditions of sale in force in the division and all other relevant Acts and Rules. Working of the lots shall also be governed in accordance with the prescriptions of the working plan in force in the concerned area. The successful bidder shall be bound to abide by all other laws and rules in force and applicable to the contract area.

11. The Acts/Rules, Working Plans/Schemes etc. cited above and the approved form of agreement to be executed by every successful bidder can be seen from the undersigned during office hours on any working day. For the convenience of the intending bidders a booklet entitled terms and conditions governing sale of timber and firewood copes and other forest produce in the office of the various forest divisions in the State with addendum is also available for ready reference. Intending bidders are advised to see this booklet and addendum in the office of the undersigned well in advance before date of auction and get acquainted with the terms and conditions.

12. For any violation of the aforesaid terms and conditions the sale or the lots concluded in favour of the highest bidders shall be quashed and put to resale in public auction immediately thereafter at the risk of the highest bidder and shortfall in sale price, if any on such resale shall be recovered from him as arrears of land revenue in accordance with Odisha Public Demand Recovery Act. In case there is no bid on such resale the original bidder shall be liable to pay the original bid amount in full.

13. The undersigned reserves the right to call for immediate deposit to the extent of 50% of the bid in shape of Demand Draft, in case the bid offered appears to be unusual to the undersigned. Only after depositing the aforesaid amount, the concerned bidder shall be allowed to progress further in bidding.

14. The undersigned reserves right to make such change/variation/alteration in the condition of sale as deemed necessary before auction sale is concluded and such changes shall be binding on all participants. The act of bidding shall be construed as sufficient evidence of the bidder having accepted all terms and conditions of sale and no complaint/ claim shall be entertained under any circumstances.

2. Payment of sale value (Highest bid amount) :

After the highest bid amount is accepted by the Divisional Forest Officer, subject to ratification of sale by the competent authority that amount will be paid in fom of deposit at call/Bank Draft drawn in favour of the Divisional Forest Officer, Berharnpur Division, payable at State Bank of India, Berhampur in the following manner :—

(i) When the highest bid amount is Rs. 50,000 or below : 50% of the bid amount shall be paid by the highest bidder immediately after fall of hammer and the balance 50% shall be paid within 07 (seven) days from the date of auction sale along with the sales tax clearance certificate/non-assessment certificate as the case may be.

- (ii) When the highest bid amount is Rs. 50,000 and up to 1,00,000 : 40% of the bid amount shall be paid by the highest bidder immediately after fall of hammer and the balance 60% shall be paid within seven days from the date of auction sale along with the sales tax clearance certificate/non-assessment certificate as the case may be.
- (iii) When the highest bid exceeds Rs. 1,00,000 : 30% of the bid amount shall be paid by the highest bidder immediately after fall of hammer and the balance 70% shall be paid within seven days from the date of auction sale along with the sales tax clearance certificate/ non-assessment certificate as the case may be.
- (i) Sale of cashewnut from each of the plantation lots as specified in the sale notice shall be subject to all relevant provisions of the Orissa Forest Act, 1972 and the rule framed thereunder, Orissa Timber and Other Forest Produce Transit Rules, 1980, Orissa Forest Contract Rules, 1966 and also the relevant general and special conditions prescribed for the sale of forest produce in public auction.
 - (ii) Necessary work order will be issued by the Divisional Forest Officer, in the favour of the highest bidder stipulating therein such of the above conditions, which are most relevant to the issue.
 - (iii) Necessary agreement in the prescribed form shall be executed by both the parties duly filling therein the highest bid amount, leasehold areas (specified), mode of payment of the sale value and all other conditions of sale before issue of the above order so as to allow collection of cashewnut sold in the auction.
 - (iv) The lessee should maintain depot register and such monthly returns in the prescribed forms showing therein progress of collection, storage and dispatch of the cashewnut of various destination so as to reach the o/o the Divisional Forest Officer/Range Officer concerned within 7 (seven) days of the month following the month to which it relates.
 - (v) The lessee shall apply to the Divisional Forest Officer for approval of necessary nomination of all his agents in the prescribed form which should be get duly approved by the Divisional Forest Officer, before engaging them in collection of cashewnut sold in auction on his behalf.
 - (vi) The lessee should obtain prior approval of the Divisional Forest Officer to the exact location of collection centers/transit depot/ storage depot including factory site etc. after giving specific description thereof.
 - (vii) Each of the approved agents of the lessee shall carry with him an identity card duly signed by the Divisional Forest Officer, containing his full name and address. His passport size photograph (duly attested) specific description of the leasehold area and such other relevant particulars as would be prescribed by the D.F.O.

- (viii) Transit of collected cashewnut from the leasehold areas to different destinations shall be regulated under Orissa Timber and Other Forest Produce Transit Rules, 1980.
 - (ix) No complaint regarding the quality and quantity of the cashewnuts sold and produced from the leasehold areas will be entertained after the sale is concluded and the act of bidding be considered as acceptance of the aforesaid terms and conditions by way of the highest bidder and any complaint regarding shortfall in produce not be entertained under any circumstances whatsoever thereafter.
 - (x) The lessee shall collect cashewnuts only. No trees or branches shall be cut/removed/ girdled/lopped or otherwise damaged during the operation.
 - (xi) No bidder shall be allowed to enter into the contract (leasehold) area before receiving the letter of authority, i.e. work order of the D.F.O.
- (xii) For the purpose of the jurisdiction in the event of dispute, if any the contractor or agreement deemed to have entered at the town where the agreement is signed on behalf of the Government within the State of Odisha and it is agreed that neither party to the contract (agreement) will be competent to bring about a suit in regard to the matter covered by the contractor for agreement at any place outside the State of Odisha.
- (xiii) Auction register should be maintained and the name and full address, both present and permanent of all the participants should be entered in the register with their dated signature.
- (xiv) For any violation of the aforesaid acts/rules/terms and conditions, the sale of the lot concluding in favour of the highest bidder shall be quashed and the E.M.D., security deposit or part/full sale value paid by him will be forfeited to Government and the lots shall be put to resale in the public auction immediately, thereafter at the risk of the bidder and the shortfall in the sale price, if any on such resale shall be recovered from him as the arrears of land revenue in accordance with the rules and procedures prescribed for filling certificate case. In case of price received in such resale is more than the accepted bid amount, the original bidder shall not be entitled that excess amount. In case no bid is offered on such resale, the original bidder shall be liable to pay the original bid amount in full.
- (xv) The successful bidder shall be required to pay the Odisha Value Added Tax (VAT) at 5 % and required income tax of the total bid amount of the cashewnut lot knocked down in his favour.

The undersigned reserves the right to reject any bid deemed proper without assigning any reason thereof. The act of bidding shall be deemed complete and unreserved acceptance of these terms and conditions of sale.
