And whereas, if the e-way bill is not generated by the registered person under sub-rule (2) and the goods are handed over to a transporter for transportation by road, the e-way bill shall be required to be generated by the said transporter in the manner prescribed in sub-rule(3) of Rule 138;

And whereas, in the pre-GST period, there was no provision of e-way bill under the Odisha Value Added Tax Act 2005 and rules framed thereunder for intra-state transportation of goods within Odisha;

And whereas, it is being felt that the stakeholders need some more time to get acquainted with the e-way bill provisions for intra-state movement of goods within Odisha.

Now, therefore, in exercise of the powers conferred by Clause (d) of sub-rule (14) of Rule 138 of the Odisha Goods and Service Tax Rules, 2017, read with Section 168 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), I, Saswat Mishra I.A.S., Commissioner of State Tax, after consultation with the Chief Commissioner (Central Tax), Bhubaneswar, do hereby specify that no e-way bill is required to be generated by any registered person under sub-rule (2) or (2A) or

any transporter under sub-rule (3) of Rule 138 for transporting goods of consignment value exceeding Rs. 50,000 from a place within Odisha to another place within Odisha.

Notification has also been issued under sub-rule (5) of Rule 138A specifying that the person-in-charge of the conveyance transporting goods of consignment value exceeding Rs. 50,000 from any place within Odisha to another place within Odisha shall carry the following documents instead of the e-way bill, namely:—

- (a) tax invoice or bill of supply or bill of entry; or
- (b) a delivery challan, where the goods are transported for reasons other than by way of supply.

This Notification shall come into force with effect from the 1st of April, 2018.
