SUBJECT-Empanelment of State Level Observers (SLOs.).

For good governance and efficient service delivery, it is necessary to monitor delivery mechanism and process constantly in programme implementation. Public grievance is one of the indicators of the performance of cutting edge level officers at grassroot in implementing a Government programme or scheme. For successful implementation of a programme by reaching the desired level, robust delivery mechanism has to be put to place and processes have to be transparent. Hence, feedback from independent sources, i.e. other than implementing and supervising authorities in the system is a must for removing deficiencies, if any, and to ensure proper implementation of the programme.

2. Therefore, it is felt imperative to have a panel of State Level Observers **(SLOs.)** at the State level to monitor the implementation of various programmes/schemes at the field level. The intention is to observe and submit feedback on proper implementation of the programmes/schemes with fail-safe delivery mechanism and transparent process. The related field level intervention is changeable from time-to-time as per urgency/ priorities. Further their services may also be utilized for effective disaster management during the occurrence of the natural calamities in the State.

3. Hence, it was decided by the Government, the officers from Indian Administrative Service (IAS), Indian Forest Service (IFS), Odisha Administrative Service (OAS), Odisha Finance Service (OFS) cadres, not below the rank of Deputy Secretary and those who are willing to walk an extra mile would be empanelled into the 'POOL of OBSERVERS' for deployment, to monitor implementation of various programmes/schemes at the field level and also for effective disaster management during natural calamities in the State.

4. Further, the following modalities are to be followed while deploying SLOs. for any specific task :---

- (i) Planning and Convergence Department is the Nodal Department for the SLOs.
- (ii) Before any assignment, the observers may be briefed about the tasks and they are required to debrief the Chief Secretary, Odisha/Development Commissioner-*cum*-Additional Chief Secretary after undertaking the tour with their feedback.
- (iii) They will submit their written Report to P.&C. Department after debriefing is over.
- (iv) Parent Department will provide the conveyance, if needed, for their journey from State Headquarters (SHQ) to the District Headquarters (DHQ) and back.
- (v) The concerned Collector of the destination district will arrange for the accommodation, logistics support and conveyance from District Headquarters to destination, etc. if required.

5. After due scrutiny and approval of the Committee formed for the purpose, the following Officers are hereby designated as State Level Observers (SLOs.) for monitoring various Programmes/ Schemes, etc. implemented in the field.
