**S. R. O. No. 234**/2018—Whereas, with the coming into effect of Rule 138 and 138A of the Odisha Goods and Services Tax Rules on 1st day of April 2018, subject to the exceptions provided in sub-rule (14) of Rule 138, e-waybill became mandatory for both inter-state and intra-state (i.e. from a place within Odisha to another place within Odisha) transportation of goods of consignment value exceeding Rs.50,000,

Whereas, to allow adequate time to the stakeholders of the State of Odisha to get acquainted with the e-waybill provisions for intra-state transport of goods, Notification No. 5199-CT., dated the 31st March 2018 had been issued under Clause (d) of sub-rule 14 of Rule 138 read with Section 168 of the OGST Act, dispensing the requirement of e-waybill by any registered person or any transporter for intra-state (i.e. from a place within Odisha to another place within Odisha) transportation of goods of consignment value exceeding Rs.50,000;

And whereas, Notification No. 5205-CT dated the 31st March 2018 had also been issued under Rule 138A, prescribing the following documents, instead of e-waybill, to be carried by the person in-charge of a conveyance transporting goods of consignment value exceeding Rs.50,000 from a place within Odisha to another place within Odisha :

- (a) tax invoice or bill of supply or bill of entry; or
- (b) a delivery challan, where the goods are transported for reasons other than by way of supply;

And whereas, as per the decision of the GST Council, e-waybill has to be mandatorily generated for intra-state transportation of goods of consignment value exceeding Rs.50,000 from 1st of June 2018;

Now, therefore, Notification No. 5199-CT, dated the 31st March 2018 issued under Clause (d) of sub-rule 14 of Rule 138 of the OGST Rules and Notification No. 5205-CT, dated the 31st March 2018 issued under Rule 138A are hereby withdrawn w.e.f. the 1st June 2018. With the withdrawal of aforesaid Notifications, every registered person or transporter shall be required to generate e-waybill for intra-state (i.e. from a place within Odisha to another place within Odisha) transportation of goods exceeding Rs.50,000 with effect from the 1st June 2018. Moreover, the person in-charge of a conveyance transporting goods of value exceeding Rs.50,000, from a place within the State to another place within or outside the State, shall be required to carry an e-waybill in addition to the tax invoice or bill of supply or delivery challan, as the case may be, as prescribed in Rule 138A with effect from the 1st June 2018.

This notification is issued after due consultation with Chief Commissioner (Central Tax), Bhubaneswar Zone, Bhubaneswar.

### SCHEME FOR "COACHING FOR EXCELLENCE"

No. 6117—PT1-SYS-CC-CC-0005/2017-SYS.—Government in Sports & Youth Services Department has been pleased to introduce a New Scheme "Coaching for Excellence". This Scheme will come into force with effect from the date of issue of this notification.

### 1. AIM & OBJECTIVES:

The scheme 'Coaching for Excellence' aims to provide expert coaching to sportspersons in various disciplines, guide them to achieve excellence in Sports as well as broad base and promote various sports discipline in the State.

### 2. KEY OBJECTIVES

- \* Train and prepare sportspersons to participate in National and International Competitions and achieve excellence in Sports.
- \* Raise the competence of the coaches through refresher courses and training.
- \* Organize Coaching Camps in various sports disciplines under the guidance of renowned coaches of national and international repute.
- \* Devise measures to take follow-up action to track the progress of the talented boys and girls spotted under the scheme

### 3. SPORTS DISCIPLINES :

Coaching camps will be organized for the inmates of the State Sports hostel in various sports discipline. The services of coaches of National and International repute will be hired to train the sports hostel students in various disciplines. During the coaching camp, coaches of international repute will supervise the priority disciplines like:

1. Hockey, 2. Athletics, 3. Weight Lifting, 4. Football, 5. Archery

Other sports discipline covered under Sports Hostel scheme of Sports & Youth Services Department will be supervised by the national level coaches.

1. Basketball, 2. Gymnastics, 3. Volleyball, 4. Swimming, 5. Wrestling, 6. Kabaddi.

Apart.from the above mentioned discipline, any other sports discipline like Badminton, Karate, Rowing etc. in which our State players are showing good result in the National/International sports events may be taken up during the coaching camps. The Sports & Youth Services Department has the right to increase or decrease the numbers of sports disciplines of the said programme.

The Honorarium/Remuneration of the coaches will be borne by the Sports & Youth Services Department.

#### 4. INTERNATIONAL / NATIONAL LEVEL REPUTE COACHES:

#### **Definition :**

**International Repute Coaches**—The coaches in the particular sports discipline have the reputation in the international level as per his/ her sports achievements or holding international coaching course organized by the concerned International Sports Federation or experience in international events as coach in Indian Contingent or recognized as a coach by the concerned International Sports Federation.

**National Repute Coaches**—The coaches in the particular sports discipline have the reputation in the national level as per his/ her sports achievements or holding national coaching course organized by the concerned National Sports Federation/NSNIS, Patiala/LNUPE, Gwalior or have coaching experience in National Sports scenario or recognized as a coach by the concerned National Sports Federation.

#### 5. DURATION OF TRAINING / REFRESHER COURSE:

Coaching camps for the sports hostel inmates and coaches will be organized twice in a year. Each camp will be of minimum 15 days durations which may be exceeded, if decided by the Sports & Youth Services Department. The annual calendar for training/refresher courses will be chalked out in consultation with the national/international coaches.

#### 6. PATTERN OF TRAINING SESSION:

The training session will consist of practical and theory classes. The practical classes will be at morning & evening and the theory classes will be 3 hours in between practical classes. There will be common classes for coaches & hostel trainees. In consultation with National/International repute coaches, a Training Time Table will be prepared by the in charge of the programme. The officer in-charge of the training/coaching camp will arrange the logistics for the theory classes and provide teaching & training aids, study materials and all relevant articles for classes.

#### 7. DEPARTMENTAL EXPERT COMMITTEE :

A Departmental Expert Committee will be constituted under the Chairmanship of Director-*cum*-Additional Secretary, Sports & Youth Services Department with the following members duly approved by Principal Secretary/Commissioner-*cum*-Secretary :

- 1. Joint Secretary/ Deputy Secretary to Govt.
- 2. F.A-cum-Deputy Secretary / A.F.A to Govt.
- 3. Under-Secretary Sports/Asst. Director, Sports
- 4. Technical Cell Members of S & YS Department
- 5. Concerned sports discipline coaches 2 representatives
- 6. Secretary of the State Sports Association of concerned sports discipline
- 7. Branch Officer of the concerned Section as Member-Convener

The Committee will select the eminent National/ International repute coach's names and the numbers of sports disciplines in which the programme will be held. The Committee will collect the information regarding their availability / remuneration/ duration with consultant to concerned National Sports Federation. The Committee will intimate the department about the commencement of programme along with budget estimate and list of consultant coaches which will be approved by the Principal Secretary/Commissioner-*cum*-Secretary. The Committee will also monitor the progress of the camp and intimate the department. Periodic monitoring meetings will be convened by the Member-Convener to assess the progress of sportspersons before their participation in major national/international competitions.

A senior coach from the concerned sports discipline will act as the 'Camp Co-ordinator'. The Camp Co-ordinator will be in charge of camp and will be responsible for facilitating the smooth conduct of the camp activities and trainings.

### 8. REPORT & EVALUATION OF THE PROGRAMME:

The 'Camp Co-ordinator' of the concerned programme will prepare a consolidate report and evaluation of the programme in which feedback of the trainees, performance assessment of the hostel trainees and overall remarks of the National! International repute coaches will be included. He/She will submit the report to this department along with the expenditur estatement of the programme.
