4. Reporting Mechanism :

The minutes of the Sub-Committee meeting will be approved by the respective Chairperson and circulated among all the stakeholders concerned. The Director, Institutional Finance will submit a separate report along with the minutes on the major decisions / issues discussed at the meeting to the Principal Secretary, Finance.

5. Input for SLBC meeting :

If any policy decision needs to be taken on any of the issues which cannot be resolved at the Sub-Committee level, the same shall form a part of the Agenda for next SLBC meeting. Issues already resolved at Sub-Committee level shall not be taken up for discussion at SLBC meetings.
