CORRIGENDUM

The 22nd April 2017

No. 10149—HE-FE-II(A)-POL-0001/2016-HE.—In partial modification of Higher Education Department Notification No. 12493-HE., dated the 24th May 2016 the sub-clause (ii) of Clause 2 is hereby substituted as follows:

"All the teaching staff appointed under Odisha Education Service in State's Scale of Pay (Method of Recruitment and Conditions of Service) Rules, 2009 and Odisha Education Service (College Branch) Rules, 1990, presently working in Govt. Jr. Colleges shall be deemed to be on deployment to School & Mass Education Department for a period of one year initially. Simultaneously School & Mass Education Department shall create equal number of PGT posts against the current sanctioned strength of 1,023 Junior Lecturers and take steps for their recruitment within a year. Guidelines for streamlining the procedure for release of foreign fishing cargo, boats, crew & fishermen apprehended in the State of Odisha owing to passing over of International Maritime Boundary Line (IMBL).

India has a vast coastline of 7516 kms bordering the mainland & islands. The Indian fishermen as well as those of the neighbouring countries sometimes cross the International Maritime Boundary Line (IMBL) in search of good catch and in the process get apprehended along with their fishing instruments and boats.

In a meeting held under the Chairmanship of Principal Secretary to Hon'ble Prime Minister of India on the 24th September 2014 regarding India-Sri Lanka fishermen issue, it was *interalia* agreed that there was a need for setting up of a Joint Interrogation Team Mechanism in all Coastal States on the Tamil Nadu Model for streamlining the procedure for release of captured foreign fishing cargo, boats, crew and fishermen etc.

For streamlining the procedure in the State of Odisha the following guidelines are hereby issued to be carried out with immediate effect.

- (1) The Secretary, Fisheries & Animal Resource Development Department, Government of Odisha is the Nodal Officer at the State level to liaise with the Indian Coastguard, Customs, Intelligence Bureau & State Police etc. The Nodal Officer will discharge the following duties :
 - (i) Prompt communication to the Central Government regarding details of vessels/men apprehended.
 - (ii) Co-ordinate for timely completion of Joint Interrogation & Communication of its report with the recommendation of State Govt. to the Central Govt.
 - (iii) Sorting out any difference between the different agencies at the field level.
 - (iv) The Nodal Officer will liaise with different concerned agencies such as Costguard, Customs, Intelligence Bureau and Special Branch of the State Police etc. There will be a periodical review preferably once in a fortnight to update the statistical data & to review the progress on action taken on such foreign vessels/ nationals apprehended.
- (2) The Collector & District Magistrate of the Districts of Balasore, Bhadrak, Kendrapada, Jagatsinghpur, Puri & Ganjam are declared as the Nodal Officer in respect of their districts.

The Districts Nodal Officers will co-ordinate the Joint Interrogation comprising Officials of Customs, Coastguards, State Police (Special Branch), Intelligence Bureau and Fisheries Department etc.

The District Nodal Officers would liaise ensure timely convening of the Joint Interrogation and the communication of its findings to the State Government.

- (3) The Joint Interrogation Committee, should meet within a week of the apprehension of the foreign vessels/nationals to finalize its findings.
- (4) The Standing Committee shall have its meeting once a month. The Committee may however have its meeting at shorter intervals based on the need that may arise.
- (5) The Committee Members are eligible for Travelling Allowance/Daily Allowance as per rules in force and expenditure on Travelling Allowance/Daily Allowance shall be debited to the Head of Account to which their pay and allowances are debited.
- (6) The following time schedule shall be observed for different stages of action to be taken (All times from day 1 of apprehension of foreign vessel/nationals).

(i)	Report of apprehension of foreign vessel/nationals	Within 48 hours through Fax/E-mail
(ii)	Conduct of Joint Interrogation & communication of its findings and recommendations to the State Government.	Within 15 days
